### **3 AGM Arrangements**

AGM usually held in May. Due to lockdown arrangements Welsh Government have amended legislations so that Community Council Meetings will be held virtually at present and that AGMs can be deferred until the end of 2020.

It was resolved to defer the AGM and Jane Hopkins confirmed she was willing to stay as Chair for the time being.

Although Pontarfynach Community Council had no objection to the original application, following the amendment to the application Community Councillors were concerned about the large scale of the development which would bring in extra noise and night light to a quite area of the Community.
