The following response was agreed upon:

"In response to the consultation of the proposed closure of Cwmystwyth Polling Station the Community Council unanimously and strongly object to the closure.

It was felt that there are adequate facilities at the Chapel Vestry, Cwmystwyth in regards to heating and toilets as well as facilities for the disabled. Parking is at present adequate but there is an intention of
