- (b) A request was received from a member of the public for the Community Council to arrange a Christmas Tree for the Village of Devil's Bridge. The Clerk had made initial enquiries regarding the proposal but prior to discussion it was understood that the arrangements for a Christmas Tree has already been made this year and that no involvement by the Community Council was necessary.
- (c) Following discussion, it was agreed to re-locate the Flag Pole by Mynach School from it's current location in the field by the School to the School's Garden. Arrangements to be made to obtain permission of the land owner of the current location to gain access for the removal.
