##### Meeting of 13<sup>th</sup> February, 2020

#### 4. MATTERS ARISING FROM THE MINUTES

- (a) Following on from the list presented at the last meeting of work outstanding the Clerk to monitor the situation with further discussions at the next meeting.
- (b) Blocked drains and ditches at Cwmystwyth have been cleaned and cleared of blockages.
- (c) R. Pratt had attended the Pentir Pumlumon Area Guide Launch Event on 27<sup>th</sup> February.

#### 5. FINANCE

- (a) The Community Council resolved to ask Ms Gill Styles to undertake an Internal Audit of the Community Council Accounts. The Clerk to issue Ms Styles with a letter of the requirements.

- (e) Although the Clerk had been presenting to the Councillors regular financial balance sheets the following receipts were not formally recorded for the 2019/20 financial year:

- (c) It was reported that individuals had started walking on the new wall from the Railway Station towards the Hafod Hotel. The Clerk to contact the County Council for signs to prevent this as it is not only dangerous but can cause damage to the wall.
- (d) Reference was made to the new Llest y Gwynt Wind Farm development in locality, but the Clerk referred that she had not received any information on the development.
- (e) Devil's Bridge Walking Club will soon be organizing a litter pick in the area, everyone is welcome to join.
- (f) Reference was made to the problem of dog fouling that exists around the Arch.
- (g) Concern over the safety of a building in Trisant where tiles and wood were blowing on the road during stormy weather.
- (h) A grant available for installing cash machines in rural villages was discussed but it was agreed that it was not practical in the area at present.
