- (b) Relocate the flag pole from the field near the School to the garden of Ysgol Mynach. Consent obtained from the landowner to access the pole. Relevant arrangements to be made for a local contractor to move the pole.
- (c) The need to fell trees opposite Capel Mynach which interferes with the street lighting at the location in question continues.

- £50.00 Clwb Pel Droed Ieuenctid Llanilar
- £150.00 Ysgol Gynradd Mynach tuag at gronfa offer cyfrifiadurol.
- £75.00 'Ceredigion Schools Rugby Union' tuag at gostau taith Rygby i'r Eidal: Un o fechgyn yr ardal wedi cael ei ddewis i fod yn rhan o'r daith.

**Donations:**

The Clerc confirmed that a letter inviting donation requests had been displayed. The following requests were received and considered:

- (c) A sunken drain near a corner near Ysgol Mynach.
- (d) Salt bin on Devil's Bridge to Cwmystwyth road needs re-installation / replacement.
- (e) The local member's request for a letter of support from the Melindwr area Community Councils to ask the County Council to look into what could be done about the Dyffryn Castell Hotel site in terms of the appearance of the site and to ensure that the buildings were not going into ruins.
