MATTERS ARISING FROM MINUTES

Following matters continue to need attention:

- (b) hedge of private property growing out onto the road at Devil's Bridge still needs attention.
- (c) A water drain between Heol Elenydd and Ysgol Mynach.
- (d) Footbridge walking from Coed y Bobl heading towards Trisant is dangerous.
- (e) The wooden sign indicating the Devil's Bridge to Borth footpath has become rotten.
