### **ANY OTHER MATTER**

#### **Following matters continue to need attention:**

- (a) Sewerage seeping in a field near  
to Heol Elenydd.
- (b) hedge of private property growing  
out onto the road at Devil's Bridge  
still needs attention.
- (c) A water drain between Heol  
Elenydd and Ysgol Mynach – The  
County Council has placed  
tarmac near to the green  
roadside verge but attention still  
needs to be given to the drain.
- (d) Footbridge walking from Coed y  
Bobl heading towards Trisant is  
dangerous.

- (e) Sefyllfa wedi gwella ychydig o'r biniau gwastraff bagiau du'n gorlifio ger y toiledau ym Mhontarfynach yn broblem unwaith eto.
- (f) Gwaith ar y draeniau dwr yng Nghwmystwyth wedi'u cwblhau gan Gyngor Sir Ceredigion.
- (g) Twll dwn ar y ffordd ger Bodcoll, Pontarfynach sydd angen adrodd i Gyngor Sir Ceredigion.
